Welcome to the PROTECTOR newsletter!

We have now recruited over 1050 patients to the study and would like to thank all those involved to date. Total recruitment currently stands at **1058 patients**. PROTECTOR is now active at **42 sites**.

- Thank you to the teams in **Edinburgh and Nottingham** who have performed very well recently! Thanks also goes to **Cambridge** for recruiting their first participants! Treats are on their way to all of you!

The data from the baseline questionnaires is really important to us and we are aiming for a 100% response rate. **We will be conducting another audit on this soon.**

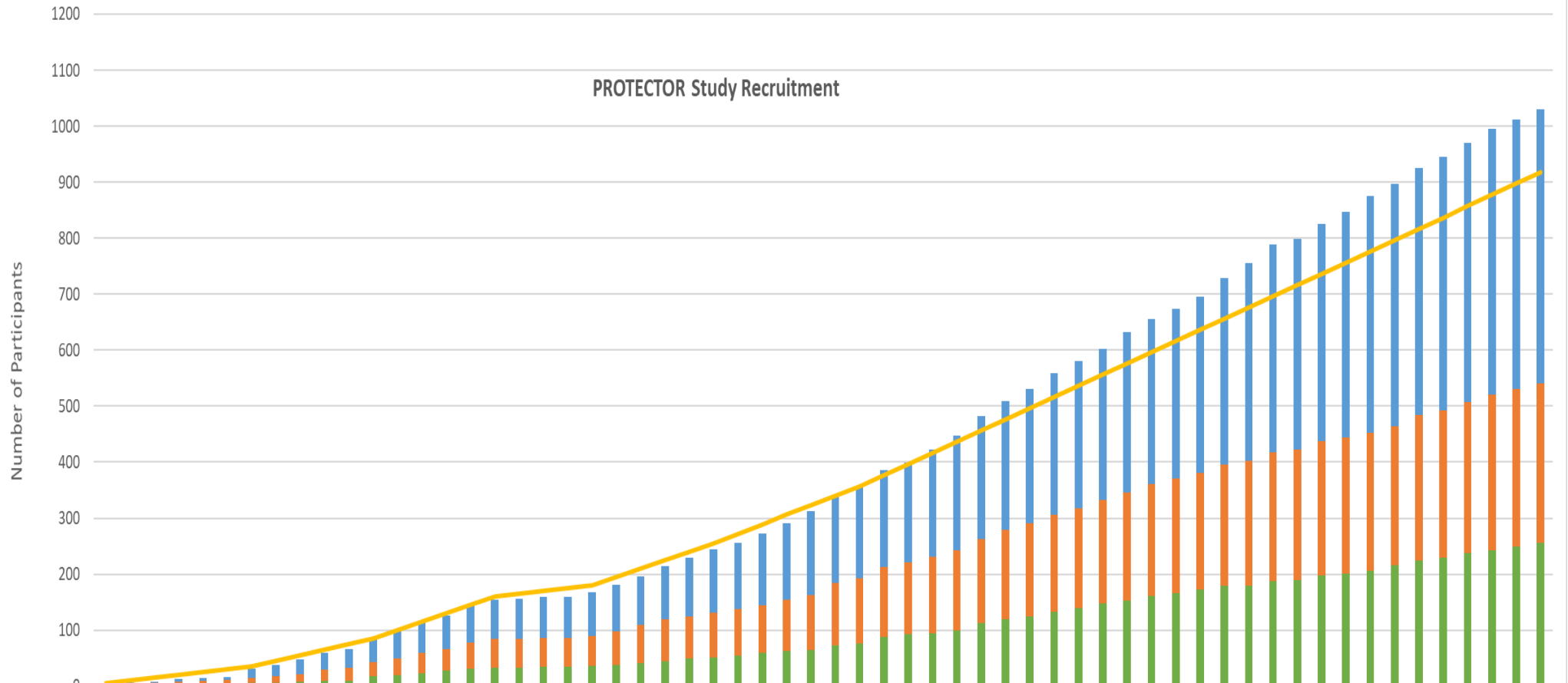
REMINDER

- The PROTECTOR study is open to BRCA1, BRCA2, RAD51C, RAD51D, BRIP1, and PALB2 mutation carriers.
- Please notify us when a participant's **surgery** is scheduled or has happened.
- Per the new SOP, please post histopathology and cytology slides and blocks to the **PROTECTOR team** following local pathology review. **Please notify us when slides are on the way and ensure slides are sent in a timely manner. Please also ensure slides/blocks are pseudo-anonymized prior to sending.**
- You can contact the PROTECTOR team at bci-protector@qmul.ac.uk. Please do not send any patient identifiable information to this email. If you need to send us identifiable information, use our NHS email: protector.study@nhs.net.
- Please keep the study database up-to-date. Patient postal addresses on the Registration form should be current so questionnaires reach them. The baseline investigations and hormonal profile forms are important to determine eligibility.
- A reminder to **please complete baseline questionnaires in clinic** wherever possible and to contact patients whose **questionnaire is outstanding**.
- Completed **Baseline questionnaires** should be posted to the below address as soon as possible. Prepaid envelopes can be requested.
