# Welcome and apologies

The Chair welcomed new members to Senate and **noted** the apologies

received.

### **Part 2: Matters for Discussion**

### **Academic Governance Review report**

(SE2024.01)

2024.002 Senate **received** a report on Phase 1 of the Academic Governance Review

and **noted** the recommendations.

Senate **noted** that the recommendations focused on six key areas; Senate's role and purpose, meetings and agendas, induction and training, stakeholder engagement, membership, and delegation and reporting.

Senate **noted** that recommendation 35 related to training on the Office for Students conditions of registration. The recommendation would be updated to clarify that it related to all relevant conditions.

Senate **noted** that some discussions currently held during Senate meetings would require alternative forums to allow Senate to focus on its particular role and responsibilities. Phase 2 of the review would consider the role of faculties in these discussions.

Senate **approved** the establishment of a working group which would consider a subset of the recommendations in more detail. The working group would consider the role of Senate members, diversity targets, ongoing support for members, and the elections process. Members were invited to express their interest in joining the working group.

Senate **approved** the direction of travel following the review and **noted** that a detailed action plan would be shared over the coming months to assist Senate in monitoring the implementation of the review recommendations. The annual survey of members would also help to track the impact of any changes.

# **Education and Student Experience Priorities**

2024.010

Presentation (SE2024.16)

2024.008 Senate **received** a presentation on education and student experience priorities.

Senate **noted** the key three priorities were: consistently delivered, world class education; consistent advice and support for students; and having graduate attributes and employability embedded into the curriculum. Thanks were expressed to those who had contributed to the ongoing work across these priorities.

Senate **noted** the activities being progressed to enhance the reach of the student voice. Student Staff Liaison Committees had been rebranded and were now Student Voice Committees which would report into the Education, Quality and Standards Board (EQSB). There was an emphasis on closing the feedback loop, allowing regular opportunities for students to provide feedback and for follow-up consideration and action to be reported back to students. Module Experience Surveys were being upgraded to increase participation and support Schools/Institutes in responding to student feedback. Endorsement from Heads of Schools/Directors of Institutes, Directors of Education and Programme Directors would be key to the success of the upgraded Module Experience Surveys. There was a target response rate of 80% for the upgraded Module Experience Surveys. The Surveys team were reviewing the annual schedule of student surveys to minimise the risk of survey fatigue amongst students. Discussions were also being held to ensure staff wellbeing was protected in relation to the nature of some of the feedback received.

## **Intellectual Property Policy**

(SE2024.02)

- 2024.011 Senate **received** the draft Intellectual Property Policy.
- Senate **noted** that the policy had been updated to align with current best practice, meet government and UK Research and Innovation (UKRI) requirements, and to ensure it was legally robust.
- Senate **noted** that the Doctoral College would provide feedback after the meeting on possible implications of the revisions for Postgraduate Research (PGR) students.
- Senate **noted** that paragraph 6.3.4 referred to the inclusion of unpublished research in Teaching Materials. On occasion, teaching staff may wish to share ideas with students which they may in the future wish to publish. Senate members agreed that this paragraph would be discussed further after the meeting.
- Senate **noted** that paragraph 6.6.2 stated that employees should contact the Joint Research Management Office (JRMO) should they wish for software and/or data created during their employment to be licensed by Queen Mary on an opensource basis. The wording would be reviewed to make sure it was clear that it related to licensing agreements. Further consideration would be given to students who may wish to publish data via GitHub to ensure the policy did not create unintended barriers to those students.
- Senate **noted** paragraph 7.3.1 would apply to all students who collaborated on taught and research degrees with employees. This paragraph included undergraduate students, however members noted that postgraduate students were more likely to be generating intellectual property in collaboration with employees.
- Senate **noted** that paragraph 7.3.5 referred to the option available to students to request that Queen Mary supported the commercialisation of their intellectual property as though they were an employee. This did not deviate from current practice and where applicable, the intellectual property would continue to be owned by the student.
- 2024.018 Senate **noted** that the independent review of university spin-out companies, and the implementation of recommendations by the Government and universities, had created further consistency between UK and US institutions.
- Senate **noted** that members were invited to share feedback on the Intellectual Property Policy with the Director of Governance and Legal Services by 15 November 2024. The Policy would be reviewed again before consideration by Senate in December 2024. Once approved, a communications plan would be developed to ensure the updated policy was effectively publicised to staff.

Senate **noted** the opportunity to hold 'deep dive' discussions during Senate meetings. Members were invited to suggest topics for in-depth consideration.

# Approval of membership and terms of reference for sub-boards of Senate (SE2024.10) for 2024–2025

Senate **received** the 2024–25 membership and terms of reference for the Education Quality and Standards Board, Taught Programmes Board, Research Degrees Programmes and Examinations Board, and the Partnerships Board.

Senate **noted** that there had been a reduction in the EQSB membership which aligned with recommendations emerging from phase one of the academic governance review. The review had found that the large membership size was negatively impacting upon the Board's effectiveness. The revised membership comprised more faculty-level and central staff, where previously members had been at School/Institute level. The importance of implementing mechanisms for ensuring effective engagement with colleagues at School/Institute level was noted.

2024.031 Members **noted** that the 2024–25 membership and terms of reference for the Ethics of Research Committee would be considered at the next meeting.

Senate **approved** the membership and terms of reference for sub-boards of Senate for 2024–25.

### Minutes of the last meeting held on 13 June 2024

(SE2024.11)

2024.033 Senate **confirmed** the minutes of the meeting held on 13 June 2024.

Chair's Actions (SE2024.12)

Senate **noted** that small revisions to the Academic Regulations for 2024-25 had been approved by Chair's Action. Clause 4.94, which related to third attempts for MBBS students, had been removed as this provision was now covered by clauses 2.105 and 2.106. Clauses 6.24 and 6.25 had been amended to more clearly articulate rules around progression for students studying the CertHE Applied Finance apprenticeship programme.

Senate **noted** that the Student Learning Engagement Policy had been approved by Chair's Action following an email consultation with Senate members in July 2024. Since the policy's approval, the launch of a replacement learning engagement analytics platform had been postponed by one year to September 2026.

Senate **noted** that the Marking Policy had been approved by Chair's Action following an email consultation with members in July-August 2024. The policy would be further considered by Senate in June 2025. The review would provide an opportunity to address queries around the new section on contingency marking arrangements and the 15 working-day turnaround time. It was noted that contingency marking arrangements should only be required in exceptional circumstances. Further consideration would be given to how Senate could be appropriately involved in contingency arrangements for marking while also managing potential conflicts of interest effectively.

# **President and Principal's report**

(SE2024.13)

Senate **received** a report from the President and Principal.

2024.038 Senate **noted** that although the President and Principal's report presented updates that went beyond Senate's core business, these updates provided

useful contextual information around sector developments. Members therefore agreed that the reports should continue to be included in meeting papers. Members also confirmed that they found the Vice-Principal reports useful. Consideration would be given to how information could be disseminated at Faculty and School/Institute level.

# Students' Union President's report

(SE2024.14)

2024.039

Senate **received** a report from the Students' Union President and noted:

- Welcome Fair events at Mile End and Whitechapel campuses had been a success, with over 11,000 attendees;
- the key activities that had taken place to encourage student volunteering. QMSU had nine active student-led volunteering groups, and 413 students had completed safeguarding training to begin volunteering;
- QMSU were undergoing an external review of their democratic structures, with a focus on Student Council. The first phase consisted of desk-based research and stakeholder interviews. Once drafting and feedback had concluded, QMSU would engage with the wider team, student representatives and Queen Mary colleagues;
- QMSU had published a statement on the recent crisis in Lebanon and were working to support the safety and wellbeing of affected students,
- QMSU were working with University colleagues on EvaSys and module evaluations to ensure the move from anonymous responses continued to protect confidentiality and promote honest reviews where possible;
- The Vice-President (Barts and The London) had been working to trial inclusive Personal Protective Equipment (PPE) that provided students with the option of accessing PPE with head coverings and full sleeves;
- The Vice-President (Humanities and Social Sciences) and Vice-President (Science and Engineering) had been working together on embedding employability in the curriculum;
- The Vice-President (Science and Engineering) had been working to implement an internship scheme for students from low-economic backgrounds;
- The Vice-President (Humanities and Social Sciences) would be conducting a survey of students who were employed alongside their studies and the impact of working on progression and retention.
